The SHE Institute - Sustainable Humanitarian Empowerment is a Think and Do Tank dedicated to research, advocacy and public policy formulation for sustainable and inclusive humanitarian action, promoting access to justice, well-being and corporate social responsibility, and encouraging private social investment.

These activities aim to contribute to the development of effective solutions to social, economic and political challenges, economic and political challenges related to issues such as migration, refugee rights, gender equality, participation and inclusion, especially in the face of new climate challenges and international conflicts.

The SHE Institute proposes to serve as a foundation for the development of a global model of Sustainable Humanitarian Empowerment, Refugee Law and International Humanitarian Law based on the United Nations Sustainable Development Goals (SDGs).

Guided by the fundamental principles of humanity, neutrality, impartiality and independence, the SHE Institute operates at the interface between research and action. intercultural mediation and actively collaborates with national and international agencies in order to and international agencies to formulate coherent public policies.



### **SHE in action**

Through excellence in research, the SHE Institute seeks to generate knowledge and information and to promote sustainable solutions to complex issues arising from the social, economic and political challenges of migration, refugeeism, gender, participation and inclusion.

We draw on experts and researchers from a wide range of fields to study and produce informed recommendations for policymakers, businesses and society at large, particularly in the areas of forced migration, refugees and statelessness; international humanitarian law (IHL); Islamic law (Sharia); women's rights and gender equality; food law (Halal); and cultural mediation.

In addition to producing scholarly articles on topics related to their areas of expertise, SHE members give lectures at various institutions, especially universities, on topics such as those mentioned above.

Furthermore, among the various actions undertaken by SHE is the support for the structuring, development and maintenance of the Chamber of Intercultural Conciliation, Arbitration and Mediation (CCAMI), whose scope is to manage arbitration, mediation, conciliation and negotiation procedures, among other appropriate methods to resolve conflicts submitted to it, online or in person, regardless of nationality, domicile or origin, as well as the promotion of education and the production of content on these topics.
